

## PARTICIPANT AGREEMENT, WAIVER AND RELEASE, AND ASSUMPTION OF RISK

In consideration of the services of **Backwoods Adventures, LLC.** and **Tarrant Regional Water District**, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "**BWA**" and "**The District**"), I hereby agree to release, indemnify, and discharge **BWA** and **The District** on behalf of my spouse, my children, my parents, my heirs, successors and assigns, personal representative, and anyone claiming any interest through my estate as follows:

1. I acknowledge that my participation in Kayaking, canoeing and stand up paddle boarding entails known and unknown and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, and/or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

**The risks include, but are not limited to the following:** drowning, injuries from striking rocks, trees or other objects, including other kayaks, canoes or stand up paddle boards; injuries resulting from malfunctions in the equipment; the hazards of lake, pond and river water; the forces of nature, including lightning and weather changes; the risks of exposure to insect or animal bites; my own physical condition, illness, the physical exertion associated with this activity, and my presence on the Licensed Premises.

Furthermore, **BWA** employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather, or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless **BWA** and **The District** from any and all claims, demands, or causes of action which are in any way connected with my participation in this activity or my use of equipment or facilities, including any such claims which allege negligent acts or omissions of **BWA** or **The District**.
4. Should **BWA** or **The District**, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. In the event that I file a lawsuit against **BWA**, I agree to do so solely in the state of Texas, and I further agree that the substantive law of that state shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

**By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against BWA and/or The District on the basis of any claim from which I have released them herein.**

**I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.**
